

OFFICE MEMORENDUM

Subject: Clarification regarding multi-state vendor registration under PM Surya Ghar: Muft Bijli Yojana

This in continuation to OM of even no. dated 29th May 2024 on revised process for National Vendor Registration for PMSG, wherein vendors were allowed for the multi-state registration based on the submission of request to National Programme Implementation Agency along with suitable Bank Guarantee.

2. The vendors who get registered as multi-state vendor initially, can also apply for National Vendor or for more States based on the submission of the incremental Bank Guarantee.
3. NPIA i.e. REC Ltd. has received request for multi-state registration from the vendors who are already registered in a State as a State Vendor and intend to register for additional states (one or more) under the multi-state registration.
4. In such cases, the vendor can submit a BG of Rs 2.5 Lakh per additional state to NPIA. The BG shall be valid for at least 5 years from the date of registration. NPIA shall process the application for the additional states (one or more) under the Multi-State Registration process. The existing State registration for such vendor shall continue to be monitored and governed by concerned State DISCOM with regard to BG validity, empanelment validity etc. and NPIA shall monitor BG validity/ empanelment validity with respect to the Additional State(s) registered under the Multi-State Registration.
5. Other Terms and Conditions shall remain same in respect of Vendor Registration and Management Process.

Subject: Allowing vendors of the adjacent States to work in the Union Territories(UTs) and allowing the vendors registered with one DISCOM to work with rest of the DISCOMs of the State for Rooftop Solar installation under PM Surya Ghar: Muft Bijli Yojana- regarding.

This refers to Ministry's OM of even No. dated 13.08.2024, regarding allowing vendors of the adjacent States to work in the Union Territories(UTs) for Rooftop Solar installation under PM Surya Ghar: Muft Bijli Yojana (PMSG:MBY).

2. In this regard, the table indicating the adjacent States of UTs has been modified as under:

3. Rest of the conditions in respect of allowing vendors of the adjacent States to work in the Union Territories(UTs) for Rooftop Solar installation under PMSG:MBY remains same as per the OM of even No. dated 13.08.2024.

4. Further, it is clarified that the vendors registered with one DISCOM shall also be allowed to work in other DISCOMs of that State (based on the Bank Guarantee submitted to one DISCOM), in case the concerned State has not appointed a nodal DISCOM or any other nodal agency for registering the vendors for entire State. In such cases, the DISCOM having the Bank Guarantee shall invoke the Bank Guarantee on request of another DISCOM for the vendor(s) whose performance has been found unsatisfactory by that DISCOM.

Subject: Allowing vendors of the adjacent States to work with the Union Territories (UTs) for Rooftop Solar installation under PM Surya Ghar: Muft Bijli Yojana- regarding.

Please refer to Ministry's OM no. 318/6/2022-GCRT dated 17.05.2023 and subsequent OMs regarding registration/empanelment of vendors for installation of the Rooftop Solar (RTS) in residential sector **under PM Surya Ghar: Muft Bijli Yojana.**


2. It has been observed that limited vendors are available in the UTs to install the RTS plants. To ensure than enough vendors are available in the UTs for faster implementation of the Scheme, it has been decided that the vendors registered/empanelled with the adjacent States can also undertake the work of installation of the RTS plants in UTs under the Scheme without any requirement of additional bank guarantee, as per the details mentioned in the following table:

3. Complaints against such vendors shall be handled by National Programme Implementing Agency (NPIA) which shall in turn instruct invoking of bank guarantee collected by the State/Discom concerned etc.

4. It is also reiterated that the vendors registered with one DISCOM in a state shall also be allowed to work in other DISCOMs of the same state without any requirement of additional bank guarantee as per provisions of OM No. 318/6/2022-GCRT dated 17.05.2023. States may appoint a nodal DISCOM or any other nodal agency for registering the vendors for entire State.

5. This issues with the approval of the competent authority.

Subject: Revised Process for National Vendor Registration for PM-Surya Ghar: Muft Bijli Yojana

The Government of India has approved the PM Surya Ghar: Muft Bijli Yojana on 29th February, 2024 to increase the share of solar rooftop capacity and empower residential households to generate their own electricity.

2. The scheme is to be implemented through the National Portal. The National Portal has been receiving applications from DISCOM consumers for installation of rooftop solar since the date of launch of the scheme viz. 13th February, 2024. These installations are to be carried out by vendors registered on the National Portal. The process for Vendor Registration (allowing National Registration of vendors) on the National Portal was laid down vide OM of even number dated 07th May, 2024.

3. Various stakeholders have requested for the option of Multi-state vendor registration along with National registration through the National Programme Implementation Agency. The suggestion has been considered and the process document has been amended and is enclosed. The OM dated 07th May, 2024 shall be considered revised to this extent.

Vendor Registration and Management Process

1. The National Portal has been receiving applications from DISCOM consumers for installation of rooftop solar since the date of launch of the scheme viz. 13th February, 2024. In order for consumers to be eligible for CFA, the installation of rooftop solar plants have to be undertaken by vendors who have been registered on the National Portal.
2. The process and terms of state level registration for vendors shall be unchanged as under the Phase II scheme outlined in OM No. 318/6/2022-GCRT dated 10th June, 2022 and 17th May 2023 and all vendors who have been registered under the guidelines of the GCRT Phase II scheme shall ab initio be deemed to be registered for PM Surya Ghar Scheme and their documents with the respective registering authorities (including Bank Guarantees) shall be considered for the purposes of the new scheme.
3. There shall, in addition, be a national registration and a multi-state registration. REC Limited shall be the Registering Authority for National Registration and multi-state registration at the national level. The vendors shall have to submit a bank guarantee of Rs 25 lakh for national registration and a bank guarantee equivalent of Rs 2.5 lakh per state/UTs under which registration is being sought for multi-state registration. The PBG submitted by the vendor shall be valid for at least 5 years from the date of registration or renewal of registration/empanelment, as the case may be.
4. In case a vendor registered under multi-state registration intends to register for additional states or go for national registration, it shall supplement its existing BG appropriately (Rs 2.5 lakh per additional state/UT or Rs 25 lakh for National Registration overall) and the NPIA shall register the vendor on the National Portal after the registration process.
5. National and Multi-state Registration of vendors will be valid for five years from the date of inclusion in the National Portal and can be renewed thereafter for five years, without any additional charges, provided the vendor has extended the previous submitted PBG of for another five years or has submitted a new PBG, whichever is convenient to the vendor.



6. Vendors covered under National Registration shall be eligible to install rooftop solar plants under the scheme in any district of any state. However, the vendors may indicate the states and districts where they will be operational so that they can be displayed in consumer search list accordingly.
7. Similarly, vendors covered under multi-state registration shall be eligible to install rooftop solar plants under the scheme in any district of any of the state/UTs for which they have been registered. However, the vendors may indicate the districts in these States/UTs in which they will be operational so that they can be displayed in consumer search list accordingly.

The Government of India has approved the PM Surya Ghar: Muft Bijli Yojana on 29th February, 2024 to increase the share of solar rooftop capacity and empower residential households to generate their own electricity. The scheme has an outlay of Rs 75,021 crore and is to be implemented till FY 2026-27. The administrative approval was granted to the scheme vide Order No. 318/17/2024-Grid Connected Rooftop dated 16th March, 2024.

2. The scheme is to be implemented through the National Portal. The National Portal has been receiving applications from DISCOM consumers for installation of rooftop solar since the date of launch of the scheme viz. 13th February, 2024. These installations are to be done by vendors registered on the National Portal.
3. The process for Vendor Registration on the National Portal is enclosed for necessary action.
4. This has the approval of the competent authority.

PM Surya Ghar: Muft Bijli Yojana Vendor Registration and Management Process

1. The National Portal has been receiving applications from DISCOM consumers for installation of rooftop solar since the date of launch of the scheme viz. 13th February, 2024. In order for consumers to be eligible for CFA, the installation of rooftop solar plants have to be undertaken by vendors who have been registered on the National Portal.
2. The process and terms of state level registration for vendors shall be unchanged as under the Phase II scheme outlined in OM No. 318/6/2022-GCRT dated 10th June, 2022 and 17th May 2023 and all vendors who have been registered under the guidelines of the GCRT Phase II scheme shall ab initio be deemed to be registered for PM Surya Ghar Scheme and their documents with the respective registering authorities (including Bank Guarantees) shall be considered for the purposes of the new scheme.
3. There shall, in addition, be a national registration and REC Limited shall be the Registering Authority at the national level. The vendors shall have to submit a bank guarantee of Rs 25 lakh for national registration. The PBG submitted by the vendor shall be valid for at least 5 years from the date of registration or renewal of registration/empanelment, as the case may be.
4. National Registration of vendors will be valid for five years from the date of inclusion in the National Portal and can be renewed thereafter for five years, without any additional charges, provided the vendor has extended the previous submitted PBG of for another five years or has submitted a new PBG, whichever is convenient to the vendor.
5. Vendors who have been registered at the national level shall be eligible to install rooftop solar plants under the scheme in any district of any state. However, the vendors may indicate the states and districts where they will be operational so that they can be displayed in consumer search list accordingly.
6. In case of delay in readiness of process flow for National registration, the NPIA shall follow the process of registration through physical means as required until the process flows have been adapted in the National Portal.
7. Detailed process flow for National Registration shall be implemented in the National Portal.

Subject: Empanelment of vendors under simplified procedure of Rooftop Solar Program Phase-II

This has reference to this Ministry's OM of even no. dated 10.06.2022 vide which the registration procedure of vendors for National Portal was conveyed.

2. As part of the vendor registration procedure for National Portal, Ministry has earlier notified that the vendors willing to register/empanel themselves in the National Portal may get themselves registered with the respective DISCOMs by submitting an application along with declaration (as per Annexure) and depositing a PBG of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand only) valid for at least five years.

3. Based on the request received from various stakeholders, it has now been decided that vendors shall have to submit only a single PBG of 2.5 Lakhs for the entire state. Some of the suggested options that can be exercised by the DISCOMs in this regard are as follows:

- a) The state government may authorize a specific DISCOM of the state to collect the PBG from the vendors on behalf of all DISCOMs. The DISCOM collecting the PBG will register the vendors and provide a list of registered vendors (updated periodically) to other DISCOMs for uploading the same on their respective National Portal accounts.
- b) The State government may authorize a separate agency (for e.g., SNAs) to collect the PBG from the vendors on behalf of all DISCOMs and provide a list of registered vendors (updated periodically) to all DISCOMs for uploading the same on their respective National Portal accounts


4. As the initial vendor registration was valid for only one year, requests have been received in the Ministry regarding process for renewal of vendor registration. In this regard, it has been decided that the registration of vendors shall be extended on year-on-year basis, without any additional charges, provided the vendor has extended the previous submitted PBG of 2.5 Lakh for another year or has submitted a new PBG, whichever is preferable to the vendor. In any case, the PBG of minimum Rs. 2.5 Lakh submitted by the vendor shall be valid for at least 5 years from the date of registration/renewal of registration.

5. In cases, wherein, PBG of Rs. 2.5 Lakhs have already been submitted by the vendor in more than one DISCOM of a state, only a single PBG amount of Rs. 2.5 Lakhs should be retained by any of the designated DISCOM/agency as indicated in para 3 above and remaining PBGs shall be released/returned to the vendor, within 3 months from the issuance of this letter or at

the time of renewal of registration, whichever is earlier. However, the registered vendor shall be asked to extend the retained PBG for another year at the time of renewal.

6. The state governments/DISCOMs shall notify these changes in their website along with the revised procedure, within a month of issuance of this notification.

Subject: Simplification of Procedure - Rooftop Solar Programme Ph-II.

This is in continuation of this Ministry's OM of even no. dated 02.02.2022, vide which simplification of procedure for installation of residential grid connected rooftop solar plants was conveyed.

2. In this regard, a National Portal, www.solarrooftop.gov.in, is being designed and will be launched soon. The process for installation of rooftop solar plants, starting from registering the applications to release of subsidy in residential consumers' (beneficiaries') bank account after installation and inspection of plant, can be tracked online at the national portal.
3. In order to protect the interests of beneficiaries and ensure that the vendors installing the rooftop solar plants have the requisite expertise, follow minimum specifications and standards specified by the Ministry and maintain the plant for at least five years from the date of installation, it has been decided that such vendors have to register/empanel themselves with the beneficiaries' Distribution Utility (DISCOM).
4. The vendors currently empanelled with the beneficiaries' DISCOM through tendering process under RTS Programme Ph-II will be considered as empanelled vendors for this purpose. Other vendors willing to register/empanel themselves in the Programme under simplified procedure may get themselves registered with the consumers' DISCOM by submitting an application along with declaration (as per Annexure) and depositing a PBG of Rs. 2,50,000/- (Rupees Two Lakh Fifty Thousand only) valid for at least five years. The vendors can submit the application at the Division/Circle level and the name of the vendor will be included in the list of registered/empanelled vendors within a period of one month from the date of submission of the application. Registration/empanelment of vendors will be valid initially for one year from the date of empanelment and can be renewed thereafter on yearly basis. The DISCOM will notify the registered/empanelled vendors on its website for information of residential consumers and update the same every month.
5. The registered/empanelled vendor selected by the beneficiaries will conduct the physical survey to assess the RTS capacity and guide the beneficiary on the RTS capacity that can be installed in the beneficiary's premises considering technical and financial parameters. The vendor shall also provide assistance to the beneficiary in getting necessary approvals, installing the net-meter and facilitating inspection by the DISCOM.
6. In case of any misleading information is provided by any vendor or conditions mentioned in the declaration are not met, the DISCOM will take action against the registered/empanelled vendor including blacklisting and forfeiture of PBG.

7. The subsidy available under the simplified procedure will be the same for beneficiaries all over the country. The rates of subsidy will be notified for each calendar year and will be applicable for all beneficiaries who have registered their application on the national portal during the calendar year.

10. The Firm will provide all necessary information related to installation of rooftop solar plants and Do's and Don'ts to the beneficiary.
11. The Firm will also provide name, contact number and e-mail of the person where the beneficiary can register a complaint related to rooftop solar plants installed by the Firm. This details will also be made available to the State authorities and MNRE.
12. In case of any discrepancy in terms of quality and services provided by the Firm, the concerned distribution company/Electricity Department can blacklist the Firm and encash the performance bank guarantee, apart from taking other legal actions.
13. The signatory of this declaration is authorised by the Firm and the Firm will abide by all the conditions mentioned above. In case of any misinformation or concealment of facts, appropriate legal action may be taken against the Firm by the affected parties.
14. Along with this declaration, the Firm is submitting a performance bank guarantee of Rs. 2.5 lakh valid for five years.
